1. Please refer to your application dated **10/07/2023** vide which request has been made for issue of CBN registration. It is informed that we have issued Provisional CBN Registration Number to your firm **M/s Bion Clinicals Pvt. Ltd., Pune** and the number is **Prov./AUGUST-2023/00002**. The Provisional CBN Registration Number issued to your firm is Provisional in nature and shall be valid for a period of one year from the date of its issue.
2. In the above context it is further intimated that Unified CBN Portal <https://www.cbnonline.gov.in> is now functional, hence you may initiate the process of registering your firm on the said portal immediately.
3. The registrants are also required to obtain necessary Licenses/ Permissions required under any Law/ Act/ Rules or Orders issued there under by any other authorities prior to undertaking any activities related to the psychotropic substances and a valid drug license under the Provisions of the Drugs & Cosmetics Act/ Rules.

Submission of Quarterly Returns

4. As per Rule 65 sub rule 2, of NDPS Rules, 1985, the firms having registered with the Narcotics Commissioner or CBN are mandatorily required to submit their quarterly returns in the form and manner as specified by the Narcotics Commissioner.
5. Accordingly, in order to comply with the provisions of NDPS Rules, 1985, you shall have to file the quarterly returns strictly in accordance with the time frame given under Rule 65 of NDPS Rules, 1985, failing which, your registration will be liable to be cancelled.
6. In addition, you shall also ensure to preserve the quarterly returns submitted by you in manual form as record. You may be asked to provide the information/ detail with regard to your CBN Registration, quarterly returns filed, as and when required.

This issues with the approval of the Assistant Narcotics Commissioner.
